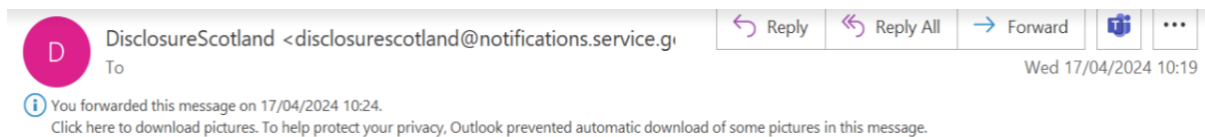


Organisations Viewing Disclosure Results Guidance

This document is a guide for organisations. It takes you through the stages of viewing disclosures results which the applicant has shared. The screen shots used have been provided by Disclosure Scotland.

1. When the online result for an application has been shared with you, you will receive a link to view the result. Click the link to access the result.



Application result
